#### Village Maintenance and Improvements

Planters

TB approached the Brill's at Peterley regarding the availability of suitable plants for the GK planters. They agreed that summer blooms would be worth waiting for. It is assumed that Pipers school would still be willing to fund those at the end of the lane.

**NAG -** Stan Jones

- It is the aim to have 2 VAS machines in the village although 3 would be ideal. There is only 1at the moment. Machines purchased would need support. GKRA stated that there are many volunteers and that this was not an issue.
- Another machine could be purchased and HPC would possibly fund 50% if the remaining funds were available. The cost is circa £2500.

### Parish Matters – Stan Jones

- HPC agreed to send a report to Rose Meech for the GKRA magazine summer edition.
- Cricket club contract is still in discussion including access to the common for other events.

• Mowing of grass by the pond was delayed due to wild flowers being allowed to grow, cutting in July. GKRA raised concern about the village boundaries with both Great Missenden and Little Missenden especially along Heath End rd.

• GKRA reported that a "Stop" road sign was now defunct at the end of Stag lane and that the 30mph sign near Ninneywood farm was obscured by tree branches on the Missenden Rd.
